




#### **Services Provided**

Our Little Haven provides professional care to enable each child's best possible functioning. Early care promotes stable outcomes for young children affected by serious challenges, including childhood trauma, abuse or neglect. Care is provided in multiple service settings at our centrally located campus. On any given day, combined services impact the lives of 70-80 children & families, helping them build foundations for their futures. 575 children were served in FY2013.

#### **Specialized care includes:**

- Keystone Mental Health Services for children and families including early mental health screenings, psychological assessment and mental health treatment/therapy by licensed psychologists and LCSWs
- Our Little Academy Therapeutic Preschool: Full day treatment for children ages 3-5 1/2 in a preschool setting
- Taylor Family Care Center: Comprehensive case management, including medical case management, for children in the foster care system
- Nurse RN on staff/on site/on call for care coordination
- Community & professional training, education & consultation.
